

## **Emeritus Professor Rosalind Croucher AM**

Emeritus Professor Rosalind Croucher AM FRSA FACLM (Hon) FAAL FRSN TEP has over 40 years' experience in the legal academy and government roles. After serving as Dean of two Australian law schools, she was appointed to the Australian Law Reform Commission, including as President for over seven years. From 30 July 2017 to 29 July 2024, Professor Croucher was President of the Australian Human Rights Commission. She has lectured and published extensively, principally in the fields of property, equity, legal history, and public policy.

Professor Croucher has received many accolades for her contributions to public policy and to the legal profession. In 2007, she was made a Foundation Fellow of the Australian Academy of Law and in 2014 she won the Australian Women Lawyers' award for her 'outstanding contribution to the legal profession' role in supporting and advancing women in the legal profession. In 2015, she was made a Member of the Order of Australia (AM) for 'significant service to the law as an academic, to legal reform and education, to professional development, and to the arts'. In October 2016 Macquarie University conferred on her the title of Emeritus Professor and, in 2018 and 2020 respectively, she was awarded honorary LL.Ds by the UNSW and Macquarie University.



## **Doctor Nikki Jamieson**

Dr Nikki Jamieson is a suicidologist, social worker, author and researcher in the fields of moral injury and suicide. Dr Jamieson has two honours degrees, a Masters and a PhD and holds adjunct positions with both Flinders University and Griffith University (Australian Institute for Suicide Research and Prevention). Currently, Dr Jamieson is a specialist advisor for suicide prevention in the Mental Health and Wellbeing Branch in Defence People Group.

Dr Jamieson also brings a lived experience of both suicide and moral injury and has led innovative research on the topics as well as being heavily involved in the recent Royal Commission into Defence and Veteran Suicide.

Dr Jamieson remains actively engaged in suicide prevention and policy and holds memberships nationally and internationally, including International Association for Suicide Prevention, Suicide Prevention Australia, Standby, Postvention Australia and with the Australian Institute of Health and Welfare. Dr Jamieson is married and outside of work enjoys spending time on the water with her husband and dogs.



## **Her Honour Sylvia Emmett AM RAN (Retd)**

Her Honour Sylvia Emmett AM RAN (Retd) graduated with the degree of Bachelor of Laws in the University of Sydney in 1981 and commenced full time practice at the Bar of New South Wales in 1988. Whilst at the Bar, Ms Emmett had a substantial practice as a Mediator and was a director of Lawyers Engaged in Alternative Dispute Resolution (LEADR) and a member of the LEADR National Accreditation Committee.



From 2002 to 2004, Ms Emmett sat as a Magistrate on the Local Court of NSW and from 2004 to 2021 as a Federal Magistrate and Judge of the Federal Circuit Court of Australia (FCCA). During Ms Emmett's time on the FCCA, she was Chair of the National Security Committee, the Finance Committee and the Judicial Education Committee of the FCCA. Ms Emmett was also a member of the Policy Advisory Committee and the Judicial Conduct Committee of the FCCA and was the FCCA's representative on the National Federal Courts Audit Committee.

From 2003 to 2021, Ms Emmett was a member of the Royal Australian Naval Reserve. During that time she presided over Boards of Inquiry into the death and serious injury of Defence Force Members and acted as a Statutory Reviewer of decisions of Defence Force Magistrates.

In 2019, Ms Emmett was appointed a Member of the Order of Australia for her 'significant service to the law, to the judiciary, and to professional legal associations'.

## Warrant Officer Janet Brennan

Warrant Officer Janet Brennan is an Air Force Health professional (Dental Manager) with over 42 years' experience.

She joined Air Force in 1982, and transferred to Reserves in Jan 2023. She held appointments across the Air Force at all enlisted levels including Dental clinical, Administration, Instructional, Health Intelligence, Aeromedical Evacuation Operations, Operational Analysis, and Senior Enlisted Advisor to Director of Air Force Intelligence Directorate.
