## Inspector-General of the Australian Defence Force

### INQUIRY INTO THE DEATHS OF FOUR AUSTRALIAN DEFENCE FORCE MEMBERS IN THE CRASH OF A MRH-90 TAIPAN HELICOPTER ON 28 JULY 2023

#### DIRECTION No.4 of 2025

#### Direction:

Pursuant to Sections 21(1)-(2) and 28M(1)-(2) of the *Inspector-General of the Australian Defence Force Regulation 2016*, and upon the ground that it is necessary to do so in the interests of the defence of the Commonwealth, I direct that:

1. Direction No.19 of 2024 that I made on 17 December 2024 and Direction No.2 of 2025 that I made on 28 February 2025, assigning pseudonyms to certain persons listed in those directions be set aside and replaced with this Direction No.5 of 2025;
2. there be no publication or other disclosure of the real names of the persons listed in the table in Annex A;
3. the persons listed in the table in Annex A be referred to in this Inquiry by the pseudonyms assigned to them, as provided in the second column of the table in Annex A;
4. when any of the persons listed in the table in Annex A give evidence at a public hearing, the video feed for the live stream of the hearing will be turned off so that only the audio of their evidence will be live streamed;
5. no visual images of the persons listed in the table in Annex A are to be published in connection with this Inquiry, however the audio of their evidence can be published; and
6. this Direction applies throughout the Commonwealth for a period of 50 years.

#### Reasons:

I have read:

1. the applications made by Special Operations Command on 26 February 2024 and 24 April 2024;
2. the applications made by Aviation Command on 12 March 2024 and 23 April 2024;
3. the application made by the Office of the Deputy Chief of Army on 19 July 2024;
4. the applications made by the Commonwealth, as instructed by Special Operations Command, on 06 and 07 November 2024; and
5. the email provided to the Inquiry by COL Fiona Wilson on 19 March 2025, together with the updated list of persons with Protected Identity Status.

I am satisfied it is necessary to make this Direction to protect the identities of Defence personnel who (i) were posted to 6 Aviation Regiment and Special Operations Command in 2022 and 2023 (ii) who are currently posted to 6 Aviation Regiment and Special Operations Command and (iii) who are likely to be posted to 6 Aviation Regiment and Special

Operations Command in the future, who are or were or will be associated with sensitive capabilities. This direction is to protect against unauthorised disclosures of the personal information of the persons whose names are listed in the table in Annex A, information regarding their association with a sensitive capability, and the sensitive capability itself.

This Direction is consistent with the Defence Security Principles Framework, Control 42.1 *Protected Identities*.

### Definitions:

“publish” means disseminate or provide access to the public or a section of the public by any means, including by –

- (a) publication in a book, newspaper, magazine or other written publication, or
- (b) broadcast by radio or television, or
- (c) public exhibition, or
- (d) broadcast or publication by means of the Internet.

“disclose” means referring to the real names of the persons listed in the table in Annex A in public, whether that be orally or in writing and includes during any of the public hearings conducted by the Inquiry. This direction, however, does not prevent a person from disclosing the real names of the persons listed in the table in Annex A if the disclosure is not by publication and it is made in the course of performing functions or duties or exercising powers in a public official capacity-

- (a) in connection with the conduct of the Inquiry or the recovery or enforcement of any penalty imposed under Sections 21(3) or 28M(3) of the *Inspector-General of the Australian Defence Force Regulation 2016*, or
- (b) in compliance with any procedure adopted by the Inquiry for informing a news media organisation of the existence and content of this Direction.

This Direction, does not prevent the disclosure of the real names of the persons listed in the table in Annex A to the Australian Defence Force if the disclosure is not by publication and the disclosure is made for the purposes of assisting the Australian Defence Force to properly implement any recommendations that the Inquiry may make.

“news media organisation” means a commercial enterprise that engages in the business of broadcasting or publishing news or a public broadcasting service that engages in the dissemination of news through a public news medium.

### Note:

Pursuant to s 21(3) of the *Inspector-General of the Australian Defence Force Regulation 2016*, a person commits an offence if the person contravenes a direction given under Section 21(1). The penalty is 10 penalty units.
